

Important Information About Pioneer Real Estate Shares

Due to the complex nature of REIT investments and the availability of their underlying tax information, tax forms for Pioneer Real Estate Shares will be mailed to shareowners in late February. Additionally, if applicable, Pioneer Real Estate Shares may report Section 199A dividends in box 5 of your IRS Form 1099-DIV.

Form 1099-DIV reports the tax character of all distributions paid to you in 2019. Form 1099-B reports your gross proceeds, as well as any reportable cost basis, related to the sale of fund shares during the year.

You should use the information reported to you on Form 1099-DIV and Form 1099-B to prepare your income tax return since Amundi Pioneer will be sending that data to the Internal Revenue Service. Shareholders who select the option to import tax documents through an electronic tax preparation software product should ensure that the information reported on this 1099-DIV is complete; otherwise, manual entry of missing tax information may be required. 2019 1099-DIV tax forms for Pioneer funds other than Real Estate Shares were mailed in late January.
